I attended the last H&I/PR meeting on October 16th. The next meeting will be on November 20th at 6:45 at The Group. The members in attendance decided to go back to using different color paper for each printing of the meeting schedule. I printed 375 copies of the schedule which I will distribute at the meeting today. I retrieved the PR materials, bins and supplies from the locker and did an inventory of the literature. I have an order of \$117.90 to bring the items back to stockpile levels. When reviewing policy I observed that some of the items listed in the stockpile didn't match the available items on the literature order form. I will be making a policy motion to correct that part of policy.

I was in contact with Rockford Mass Transit about purchasing additional tail sign. Waiting to hear back to see if one will become available because another advertiser didn't renew. Discussed other alternatives such as signs at bus stops and interior signs. Waiting for a quote/proposal. Also waiting for a proposal from Stateline Mass Transit that has routes north of 173. I was contacted by a person planning to start a meeting in Stockton, IL. They were planning to attend today's ASC to become recognized. I was in contact with another person about a new meeting in Sterling. They are planning to come to December ASC. I was in contact with a person in Freeport about getting meeting schedules and literature into the probation office, the library, and the township office there. I also have a treatment counselor request literature and schedules for their office. I will be looking at other locations in Rockford as well as other places in our area to place meeting schedules and literature soon. I submitted a request for \$64.65 to the treasurer to be reimbursed for printing schedules and purchasing supplies.

Policy and Procedure Chair: Brittany B.

The Policy and Procedure Subcommittee has reviewed the latest Policy motion, as per the request of ASC. The motion is as follows: "To amend Policy to state: Two absences will equal a resignation unless there is an emergency and that person in the position can state their emergency in the next ASC meeting.

INTENT: To provide unity within the fellowship and provide inclusion for those stepping up in service."

The subcommittee would like to remind this body that it is our job to take the policy motions that are passed at Area and find a way to integrate them into the policy. We also can review motions that seem to cause division in the body to create a broader and more sophisticated group conscience. To that end, we have reviewed the motion that was forwarded to this subcommittee and recommend that the GSR's vote no on the motion on the table. The ASC had previously decided that 2 consecutive absences without notice was required to consider a position resigned. Continued unexplained absence hurts the productivity of the area's subcommittees and hinder's the area's ability to effectively reach out to the addict who still suffers. In theory, every chairperson who reports to the Area Service Committee should

have a functioning subcommittee that could potentially report the ongoing activities of that subcommittee in the absence of the chairperson. Furthermore, we do not recommend implementing this motion because we find the term emergency to be too vague a term. One person's inconvenience can be another's emergency. Changing policy affects everyone not just a single individual in a single case. Although the committee is generally agreeable to the idea of modifying policy to prevent issues such as these, we do not believe this is the proper remedy. We suggest that the GSR's decide who the "NOTICE" needs to be given to and making that a part of policy. Also, potentially look at whether or not the submission of a report can count as attendance. These are a few remedies that we believe could help the flow of communication regarding absences and still allow for the ASC to be fully informed of the ongoing activities of its subcommittees.

Policy is up to date and I have more policy packets for anyone who needs them.
